Aims and Purposes

St Peter's Parochial Church Council (PCC) has the responsibility of cooperating with the Rector, the Revd. Jonathan Roberts, in promoting in the parish the whole mission of the church, and specifically fulfilling the PCC's Mission Statement – Glorifying God; Following Jesus; Growing Disciples; Transforming Communities'. PCC Constitution

The Parochial Church Council is a corporate body established by the Church of England and the PCC operates under the Parochial Church Council Measure. The PCC is excepted by order from registering with the Charity Commission.

Objectives and Activities

The PCC has spiritual and practical oversight of our worship, the care of the church building and mission.

The PCC is committed to enabling as many people as possible to worship in our parish church and to belong to the community of St Peter's. This is undertaken according to the doctrines and structures of the Church of England.

The PCC complies with the duty to show due regard to the House of Bishops' guidance on safeguarding children and vulnerable adults (Section 5 of the Safeguarding and Clergy Discipline Measure 2016).

Mission:

Our (benefice) Mission Statement reminds us that it is not the church of God which has a mission in the world, but the God of mission who has a church in the world.

As two churches, we are united around the **cross** of Jesus Christ, which is why this symbol is at the centre. Our mission can be summarised in four statements:

Glorifying God is the aim of every Christian (1 Corinthians 10:31). We seek to bring him the glory



due to his name through our **WORSHIP** – both corporately when we gather together (Revelation 4:9-11) and in our individual lives (Romans 12:1-2).

Following Jesus is the Christian life. Jesus called people to follow him unreservedly when he lived on earth, and today he continues to invite us with the same call – 'follow me' (Matthew 4:19). Responding to his call is the life of **DISCIPLESHIP** which is both costly and rewarding (Mark 8:34-35).

Growing Disciples is at the heart of the reason for the church's existence. In his final words to the disciples before his ascension, Jesus commanded his followers to make disciples (Matthew 28: 19-20). It has always been God's intention that his people should draw others to himself, and **EVANGELISM** and **DISCIPLESHIP** should be a normal and expected part of our life corporately and

individually. Spiritual growth in people, however, is God's work (1 Corinthians 3:6-8) and he graciously invites us into that process.

Transforming Communities is the outcome for which we hope and **PRAY** as we seek to be ambassadors for Christ in the communities to which we belong. Jesus reminds us that we, as his people, are to be salt and light - agents of transformation – in places where there is moral decay and spiritual darkness (Matthew 5:13-16). We **PRAY** for the coming of God's kingdom on earth as it is in heaven.

Achievements and Performance:

We have continued to respond to the challenges of the Covid-19 pandemic which has really dominated our life as churches and as a community. Thanks to the rolling out of the vaccination programme, we have slowly been able to reduce the restrictions in place, meeting regularly for worship and other events and serving the community in relation to some life events. Some of the other reports in this document will highlight these more clearly.

The PCC has met either virtually or in person (wearing face coverings) and coped well with the challenge both these ways of meeting have presented. We are hopeful that a more 'normal' format of meeting will continue into 2022 and dates have been set for the year.

Key areas of mission and ministry have included:

- A mixed economy of 'online' and 'in-person' worship
- Continued ministry to children and young people, including schools' work
- Connect groups
- Pastoral care networks
- Occasional offices

Some areas of mission and ministry have not been able to operate yet because of the effects of the pandemic.

3. Proceedings of the PCC

We have been able to transition from zoom meetings to in-person meetings which has helped the efficiency of our meetings which have been held throughout the year. The PCC has sought to fulfil its responsibilities diligently and significant areas of discussion and decision have included:

- Appointing PCC Officers
- Discussing our financial challenges and the deficit budget and seeking to address these
- Presenting the TAR for 2020 (including the annual financial statements)
- Reviewing worship and events generally and particularly in relation to the necessary covid measures
- Receiving reports and recommendations from the JMT in relation to funding our C&YDE and work with children and young people
- Safeguarding updates and annually reviewed policies
- Agreement to fund and extend Rector's administrator contract

- Overseeing routine maintenance of the buildings and outside areas
- Discussions and agreement of worship provision at different stages of the pandemic, including access to and the re-opening of the church building

(a) Churchwardens' Report

The last two years have been challenging for the life of our church family. The covid pandemic has resulted in the closing of our building for long periods and fractured our community as people have been isolated and unable to meet family and friends. We would like to thank so many people for their little acts of kindness during these lonely times, when many elderly or poorly people felt very sad and alone. The weekly telephone calls to chat and talk over problems, visiting when permitted, shopping, taking people for hospital or doctor's visits, praying with, and for them, all these have helped to keep our church family in touch. Particular thanks go to all those people involved in contributing to and producing the weekly bulletin and the online service, which has been an inspiring lifeline not just for our congregation, but for many other Christians around the country too. And it continues to be so for those who feel too vulnerable to mix.

Thanks go too, to all the people who have helped to get us back on our feet as restrictions have lessened, some taking on new roles where they have seen a need, such as helping cleaning the church, keeping the grounds tidy, taking on a side person role, or going on the coffee rota. After a shaky start with detailed risk assessments, shortened services and masks, it is encouraging now to see people feeling more confident and joyful about worshipping in church again. Some groups have restarted, and people are able to socialise but there is still much to do. There are still some jobs that need filling, and our church would not run smoothly without the many volunteers who give of their time and talents as part of their commitment to God.

A large part of our job is to support the clergy and congregation and we hope always to be able to help when people have questions or comments. We would like to thank everyone for supporting us in our role.

(b) Youth & Children's Discipleship Enabler Report

Throughout 2021 our focus has been '**thrive**' – a year in which, as children, young people, families, and a community of God, we don't just survive, but we flourish and prosper.

Jesus said, "a thief comes to steal and kill and destroy, but I came to give life – life in all its fullness." (John 10:10)

The hope for this year was for everything to return to 'normal' (whatever that is) and in part we seem to be at least heading in the right direction. After 17 months **x:cite** returned to St. Peter's as part of the 10am service, **Friday Club** and **Youth Fellowship** returned to meeting as whole groups at Blythe Bridge Methodist Church (via a cold stint outside on William Amory's yard – thank you so much Mr Wilken for allowing us to use the space), and **God Squad** managed to get together at McDonalds and in my garden.

It's not always been easy, and I'm sure everyone's stress levels have been high, but with some creative re-workings and some warm clothing we've worked hard at keeping everyone safe as well as encountering God together. We created '*x:cite* @ home' as a creative resource for families to use alongside the 10am online service and throughout the week based on the Bible reading, and I have no idea how we kept it going for so many weeks – Margaret and Archie were the super-stars that kept me almost sane over the months and I'm super-grateful for their input, skills and putting up with my perfectionist tendencies.

It's a great encouragement that although numbers dropped when we were online, many children and young people returned, as if we hadn't been apart, when we were able to be in the same space again. I continue to thank God for the relationships we've had for years and the new ones we're building as we rediscover the love of being together. I believe we're thriving more as we reconnect with each other as community, and it's a huge blessing to us all.

Sophie continues to be amazing with her creative talents in leading the **Messy Church** team. We've discovered that by meeting outdoors, church has become more visible and although it might not always be as warm, we don't want to lose the benefits of being a visible presence in the community. That said, the opportunity to gather together for a short act of worship in St. Peter's (with Jonathan the Christingle) in December was wonderful too. I'm sure 2022 will see more of a 'hybrid' approach (especially in the Summer 🕥).

It was wonderful to be able to welcome the **Year 7s** for their (streamlined) Christmas Service at St. Peter's again this year, even with some seating adaptations, and continue to keep in touch with ways we can support the whole school. Weekly Collective Worship videos have been produced and distributed to **Forsbrook** Primary and **Springcroft** for use in school and at home. Sam and I even managed to make it in to see the whole school at Forsbrook one Thursday before everyone went back into 'bubbles' and we look forward to less restrictions and more opportunities to do that again in 2022. Our ongoing relationships with local schools continue to be strong and as I look back over the year, I realise we're in a stronger position to continue to impact our local schools and community than many other churches – it's not a competition, but I take great encouragement that we're not starting from scratch as we step into 2022.

Funding what we do is rarely straightforward, and this year we have been blessed to have received continued funding towards my salary from The Henry Smith Charity and funds to help us run Friday Club and Youth Fellowship well during the pandemic from Staffordshire Community Foundation, on top of generous regular giving from individuals. I am personally grateful and know the children and young people in our community are closer to God, to church and to each other as a result. Thank you!

In 2022 we're looking forward with *hope*; remembering to focus on God as the source of our *hope* as we are expectant about what God might do in and through us.

I pray that God, the source of hope, will fill you completely with joy and peace because you trust in Him and that by the power of Holy Spirit you will abound in hope and overflow with confidence in His promises

(c) Tiddler's Group Report

May 2021 saw us opening tiddlers in a new way with Tiddlers Go Wild - an outdoor version of the group but running in St Margaret's Church Hall. It was lovely to welcome familiar families back along with some new faces too. Due to covid restrictions we have sought to adapt our sessions in line with local covid rates and restrictions, and it is a real joy to be back in our church building now. We have also been able to welcome back some of our older volunteers into the kitchen which has been great.

Historically Tiddlers has used the welcome room, but to keep things more covid safe, and to make the most of the space we have, we have used a large part of the worship area. It has been a delight to watch our families inside our church building listening to worship songs, playing together, and enjoying hearing stories about Jesus. And many of the carers have commented on how lovely it is that their children can enjoy exploring the area.

Louise and Archie have stepped forward as a great duo for Bible story time which is a delight to see, and Christine has kept the children entertained with some wonderful Bible themed crafts.

We have introduced a Tiddlers WhatsApp group and it is a real encouragement hearing weekly comments about how much the children have enjoyed themselves. We received this comment on the group this week

Another lovely morning - thank you to the whole team! We loved the interactive Bible story, the toast and hearing great worship songs in the background! Brill! $\checkmark A$ xxx

As our numbers have rapidly increased (25 children this week and grownups) we have adapted a process of continual improvement where we seek ways of keeping our families safe and happy whilst sharing in fellowship and friendship.

We have started doing termly Tiddler family services where we invite friends and family of Tiddlers to an all-age service and end with drinks and homemade cakes. It has been lovely to see Tiddler families coming along to our Messy Church and Christmas Wreath Making workshop too.

This week we made the decision to stop giving out biscuits, and introduce toast into our snack time. The kitchen was kept very busy but rose to the challenge tremendously resulting in very happy tiddlers and grownups.

Going forward to this year we continue to look for ways to minister to these families, and are looking forward to a summer day out for the families.

(d) Messy Report

As we've journeyed through the changes of rules that have come into place as we learn to live with Covid 19 this year, we have enjoyed being able to reach out to so many families during key events of the year in Messy Church.

The Messy Church leadership team has grown in number, and it has been a delight to welcome new leaders whilst continuing to be blessed by our original Messy Church Team.

At Easter we had 130 children following trails around our village, scanning QR codes which were attached to giant eggs, to hear the true story of Easter. It was lovely to see the buzz of so many families enjoying the fresh spring air, local walks and hearing the good news that Jesus died for them. When they finished the hunt they were gifted eggs and an Easter story which was made all the more possible by the great support of Tesco Meir and some generous donors.

On 31st October on a night which would usually see our village bustling with ghosts and ghouls, the Messy Church team came together to unite in God's light as superheroes. 150 children joined in and enjoyed searching for the heroes around the village whilst filling goodie bags with sweets that were kindly donated by Spar Forsbrook, Tesco Blythe Bridge and Meir, and some of our Messy Church Team. When they finished their hunt it was a joy to welcome them onto our church car park to enjoy homemade pumpkin soup using locally grown pumpkins, hotdogs from our local butchers and fun and dancing. It was especially moving to see our Leaders' photo on the front page of the Blythe Times as a salute to good overcoming evil.

At Christmas it was a real blessing to be able to welcome some of our families back into church for our Messy Nativity and Christingle. 20 families enjoyed crafts and Christingle making on the carpark whilst being serenaded by our wonderful choir, and joined by our good friends at the Olcote Sanctuary who brought some of their animals along. We ended with a service inside church, and it was particularly moving to sing Away in a Manger together whilst watching our candle flames and remembering Jesus being the light of the world.

We give thanks for the hard work and enthusiasm of all of the Messy Church Team, and look forward to hopefully being back inside the church building for some of the future Messy Church Services.

(e) Connect Group/Zoom Bible Study Report

'Connect' continued to meet during the first part of the year online, through Zoom, with both morning and evening sessions functioning with a combined number of 16 being involved. This was quite an encouraging number and several people who previously had been unable to be involved in the in-person sessions were able to participate through Zoom. However it was a great relief and source of joy when we were able, in late summer, to meet again in person with both the morning and evening sessions at St Margaret's and St Peter's recommencing. The first study we completed was on the Bible's teaching on 'Contentment' followed by a study on what Biblical teaching is on the Church. Both the morning and evening sessions have

attracted between eight and twelve people a week which is a pleasing number. We pray that as we continue to move forward post covid others will return as well as new people joining.

Participants continue to say how important the sessions are for them in their growth as Christian disciples.

Last year we set out our hopes for the future of Connect and, with hope and confidence in God, we carry them through into the coming year.

- 1. It would be wonderful to have more people on the rota to lead the Bible Studies [even just once every couple of months would be great]. Those volunteering don't have to be a trained expert as detailed leaders' notes are provided.
- 2. Above all though we would like more people to come along and share in the Bible studies and to bring their own unique insights and life stories to the groups. We share and learn together.
- 3. It would also be good, if anybody felt God's leading, to offer their home for a group to meet at some other time. Help would be given to anyone willing to lead such a group.

Above all we pray for the Lord of the Scriptures to continue to use Connect as a major way for the church community to grow in discipleship and in the love of His Word.

(f) Choir Report

This year has been a much better year for us although we are still a way from being normal again. Just in time for the Easter service the church was once more open for services in the building. Masks were mandatory and we had to sit in the congregation rather than in the choir stalls. No singing was allowed inside but we did get to hear hymns played via the iPad. We were however allowed to sing outside (weather permitting). It felt so good to actually sing again but some of us did find our voices a bit rusty after a year not singing. Singing in church was eventually permitted but masks are still being worn and we are still not back in the choir stalls. We do now have the organ to accompany our singing which makes a huge difference. Our grateful thanks to lan.

The carol service did take place this year but in a very different format. There were only communal carols and no choral pieces from the choir. We did however as a choir go out a few weeks before Christmas and sing carols for two choir members who cannot get to church. This was very much appreciated by both members, and we all felt good to be singing as a choir. We were joined on this occasion by a special junior chorister who we hope will join us permanently when she is a bit older.

Choir practices resumed after Christmas albeit only once a month for a short stretch after the evening service. We brushed up on our choral responses and have also been learning a new setting for the evening prayer service responses.

On a sad note we have had one member of our choir who has had to retire on health grounds. The rest of us still keep going but like everyone are starting to feel our age. We would love to recruit new members, but interest is very low. (Too many other demands on people's time I guess)

We hope as restrictions are lifted and people try to return to a "normal" life that things will soon get back to normal in church.

(g) Rector's Report

This has been an unpredictable and challenging year for many of us if different ways as we have sought to follow Jesus both individually and as a church.

A pandemic which has continued far longer than any of us would have imagined has brought great challenges and also great opportunities and reminds me of the need to 'run with perseverance the race marked out for us, keeping our eyes fixed on Jesus, the pioneer and perfecter of faith' (Heb 12:1-2).

The challenges of the pandemic have rippled through our lives personally and as a church. I hope that if you have been able to serve in any way this year, visibly or behind the scenes, you will accept my expression of sincere thanks here, both personally and on behalf of those who have been blessed by you.

As we continue our journey as God's people in this place, we do so with a sense of lament for what has been lost, thankfulness for what God has provided and taught us and anticipation for what is to come. We will need to cultivate attentiveness to the promptings of the Spirit and prayerful trust in Jesus Christ as he leads his church into the coming year

(h) Safeguarding Report

St Peter's Church PCC is committed to caring for all the children, young people and vulnerable adults who participate in any aspect of our church life. The safety and security of children, young people and vulnerable adults is of the utmost importance and the Church of England guidelines and policies underpin this.

As reported last year Safeguarding is a standing item on the PCC Agenda, thus ensuring through the Rector and the Parish Safeguarding Officer, members are regularly informed and updated to ensure the PCC complies with its responsibilities. There have been no safeguarding concerns reported to me during 2021.

The Safeguarding Policies for Children and Young People and Vulnerable Adults were reviewed and updated at the beginning of year and presented to the PCC for approval on 8 March 2021. Both these policies were approved and can be viewed on St Peter's Church website at www.stpetersforsbrook.org.

DBS Requirements:

In accordance with the Church of England safeguarding procedures, clergy, lay readers, PCC members, volunteers and staff members who hold a DBS Certificate are required to renew them every 5 years. During 2021, 7 people's certificates expired, except for 2 individuals, these were renewed accordingly. The two volunteers who did not renew their certificates no longer undertake a voluntary role within the church. 1 new volunteer was recruited whose role required a DBS Check.

Training Requirements:

With regarding to Safeguarding Training, the National Safeguarding Team have advised that the Basic Awareness and Foundation online training modules (formerly Co and C1) are now of such a high standard that they meet the training needs of all lay volunteer leaders in churches, including church wardens. However, those who hold a Bishop's Licence or Commission, including lay readers are required to complete the additional Leadership module. All our Lay Readers have completed the relevant training which is still valid. 3 people have completed the Basic Awareness and Foundation modules during the year.

Thank you to everyone who completed online DBS Applications, training or attended additional training courses, for giving their valuable time and commitment, ensuring we meet our obligation to safeguard children, young people, and vulnerable adults within our church community.

(i) Eco Group Report

The Eco Group was formed in October 2020 to help care for God's Creation.

These are the aims:

- To help control climate change
- To reduce energy use by St Peter's

- To minimise use of resources by St Peter's
- To encourage members to adopt sustainable lifestyles
- To encourage all people to adopt sustainable lifestyles
- To organise practical work to improve the environment
- To encourage governments and other organisations to support sustainable proposals

Progress has been slow due to the pandemic, and no actions were really started until late in the near. A number of more specific actions have been identified for 2022. These include:

- Cover the environment in prayer
- Better control of heating
- Maximise recycling at church
- Install bird boxes
- Community litter picking
- Environment features in church bulletin, magazine, and website

The potential for solar panels, insulation and LED lighting are being considered by the Building & Grounds Group.

The group members are:

Several other church members have indicated they would help with some actions. The Methodist Church is also considering their environmental position, and joint action is proposed for the community litter picking.

5. St Peter's Parochial Church Council Financial Report and Statements 31st December 2021

2021 was a very challenging year for St Peter's regarding its financial situation and have been unable meet its contribution in full for the 2021 parish share. This was despite of the generous giving of the church family and a kind contribution from the Diocese. The payments in 2021 were made through regular monthly payments but were only just over half that expected. We would normally pay any large unrestricted surpluses we have accumulated over the year towards the parish share but owing to continued lockdowns and delays in payments we were not able to meet this obligation. The Parish Share is being replaced by the common fund and the amount due is like that of the 2021 parish share. The current proposal is to pay a similar monthly amount to the common fund and to pay any additional surpluses we have towards this amount as a lump sum towards the end of the year.

With the partial reopening of the physical services in 2021 St Peters did see a slight increase in cash donations. Owing to the timings of the lockdowns the giving in grace initiative was not implemented and is planned for 2022. Overall giving was slightly less than 2021 except for a large generous legacy payment for restricted funded projects.

In the financial statements, it can be seen that the youth fund has been built up steadily. This was owing to the kind £20K grant from the Henry Smith Charity in 2020 that was restricted for use to cover the costs of employing a skilled Children's and Youth Discipleship Enabler. The funding was almost all used up in 2021 and will need to use the youth fund to support this work going forward. The work has really enabled many children and young people in their faith development (see Children's and Youth Discipleship Enabler Report) and continues to strengthen our partnerships within the community.

The funding to support the work of our Children's and Youth Discipleship Enabler is continuing for the majority of 2022 by using the remainder of the Henry Smith grant and through contributions built up over several years from the wider community whilst we had the grant funding in place. The funding for the post of Rectors administrator has been secured for 2022 through kind donations of the St Peters and St Margaret's community and by reallocating funds from another fund (social fund)

St Peter's relies heavily on the generosity of its' congregation to flourish, and the PCC continues to be grateful for this, however, it also relies heavily on all the volunteers who give up their time and offer their skills but there is always room for more volunteers to support the work of the Church, this can be by:

- Supporting the work of the Tiddlers Group who meet every Tuesday
- o Support the work of the Messy Church team
- Connect Bible Study groups
- Helping out during the services by
 - operating the sound system and/or projector
 - be willing to read one of the Bible readings
 - lead our intercessions
 - be a Sides-person
 - provide refreshments
 - be there to say hello and welcome to a visitor
- Helping the Ministry Team
- Supporting the Pastoral Team
- o Be part of the Flower Arranging Team/Brass Cleaning Team
- Help the Building Committee

The list is endless, and I am sure I will have missed something out, but this is something you can be part of, why not ask a member of the PCC for more information.

Notes to the Financial Statements For the year ending 31st December 2021

Introduction

The role of the Independent Examiner is to provide an independent scrutiny of accounts and the examiner plays a part in maintaining public trust and confidence in the PCC. The Independent Examiner's Report can be found on the back page of this report. All financial reports are taken from Myfundaccounting which is the software that is recognised and approved by the Dioceses in the Church of England for use by Treasurers and Gift Aid Coordinators.

Accounting Policies

The financial statements have been prepared in accordance with the Statement of Recommended Practice for Charities (SORP) and applicable accounting standards (FRSSE) or (FRS102).

The financial statements have been prepared under the historical cost convention. The financial statements include all transactions, assets, and liabilities for which the PCC is responsible in law. They do not include the accounts of church groups that owe their main affiliation to another body nor those that are informal gatherings of Church members.

The Financial Statements have been prepared using the Receipts and Payments method and therefore are shown as such and a statement of assets and liabilities.

There may be minor discrepancies in the totals as the pence are not being shown

Funds

General funds represent the funds of the PCC that are not subject to any restrictions regarding their use and are available for application on the general purpose of the PCC. Funds designated for a particular purpose by the PCC are restricted.

The accounts include all transactions, assets, and liabilities for which the PCC is responsible in law.

Incoming Resources

- Voluntary income and capital sources
- Collections are recognised when received by or on behalf of the PCC.
- Planned giving receivable under Gift Aid is recognised only when received.
- Income tax recoverable as Gift Aid donations is recognised when the income is recovered.
- Grants and legacies to the PCC are accounted for when the income is received.
- Funds raised by fairs and similar events are accounted for gross.
- Sales of books and magazines from the church are accounted for gross.

Other Income

Rental income from the letting of church premises is recognised when the income is received.

Income from Investments

Dividends are accounted for when due and payable. Interest entitlements are accounted for as received.

Gains and losses on investments

Realised gains or losses are recognised when investments are sold.

Unrealised gains and losses are accounted for on re-valuation of investments at 31 December 2021.

Resources Used

Grants and donations are accounted for when paid over, or when awarded, if that award creates a binding obligation on the PCC.

Activities directly relating to the work of the Church

The whole of the Diocesan Parish Share is accounted in this financial year.

Fixed Assets

Consecrated property and movable church furnishings

Consecrated and beneficial property of any kind is excluded from the accounts by $s_{96}(2)(a)$ and

(c) of the Charities Act 1993.

Movable church furnishings held by the Clergy and Churchwardens on special trust for the PCC,

and which require a faculty for disposal, are accounted as inalienable property unless

consecrated. They are listed in the church's inventory, which can be inspected at any reasonable

time. There is insufficient cost information available to facilitate inclusion of these assets in the accounts.

Other fixtures, fittings, and office equipment

All such expenditure relating to beneficed or consecrated property is written off in the year of acquisition.

Other property

Other church buildings are included in the accounts as deemed or actual costs if known.

Investments

Investments are valued at market value at 31 December 2021.

A further year of only a few small works achieved: lightning conductor tested; new sump pump fitted; and fire alarm battery replaced. Potholes were filled in the car park; mainly by a local resident in the building trade; our thanks to him.
